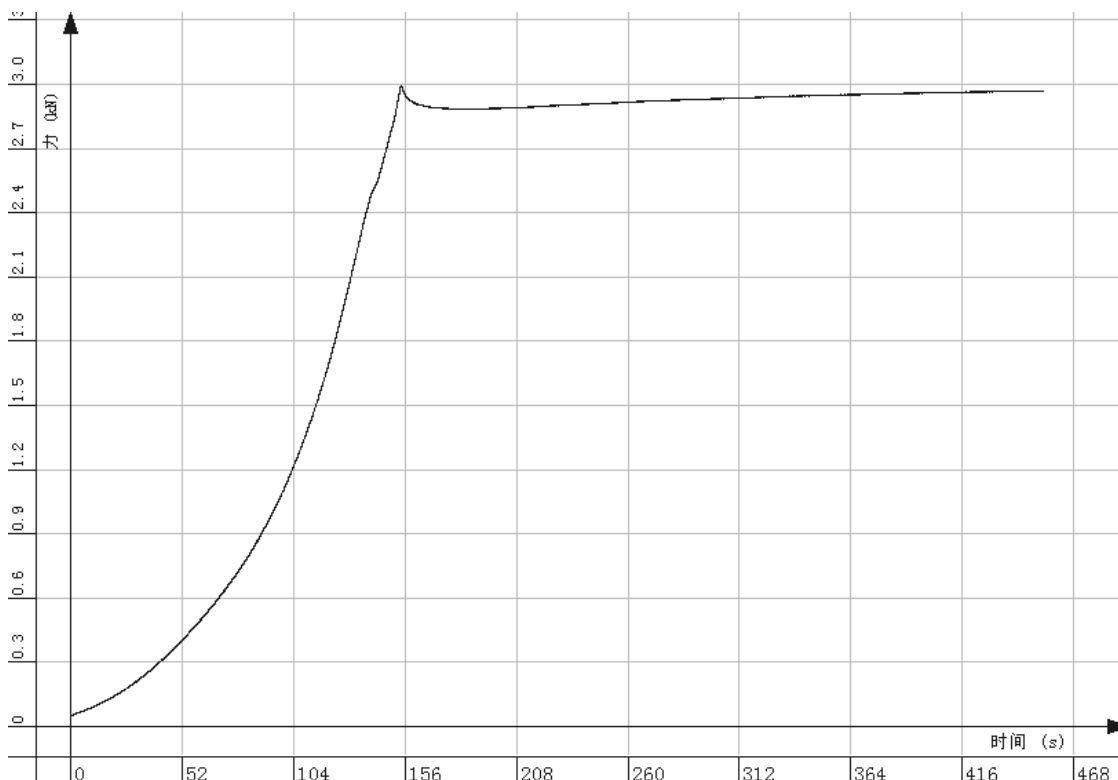
Pull test:

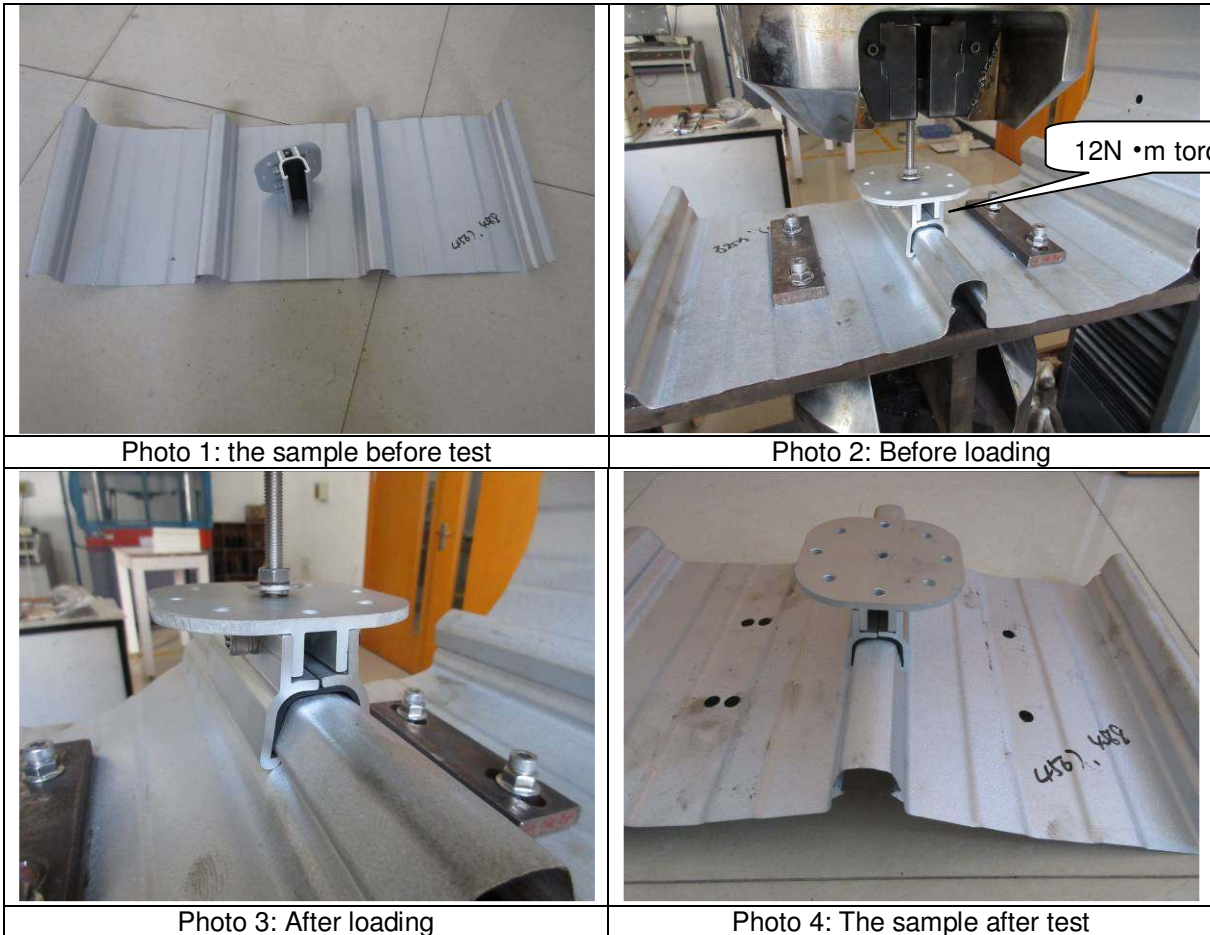
