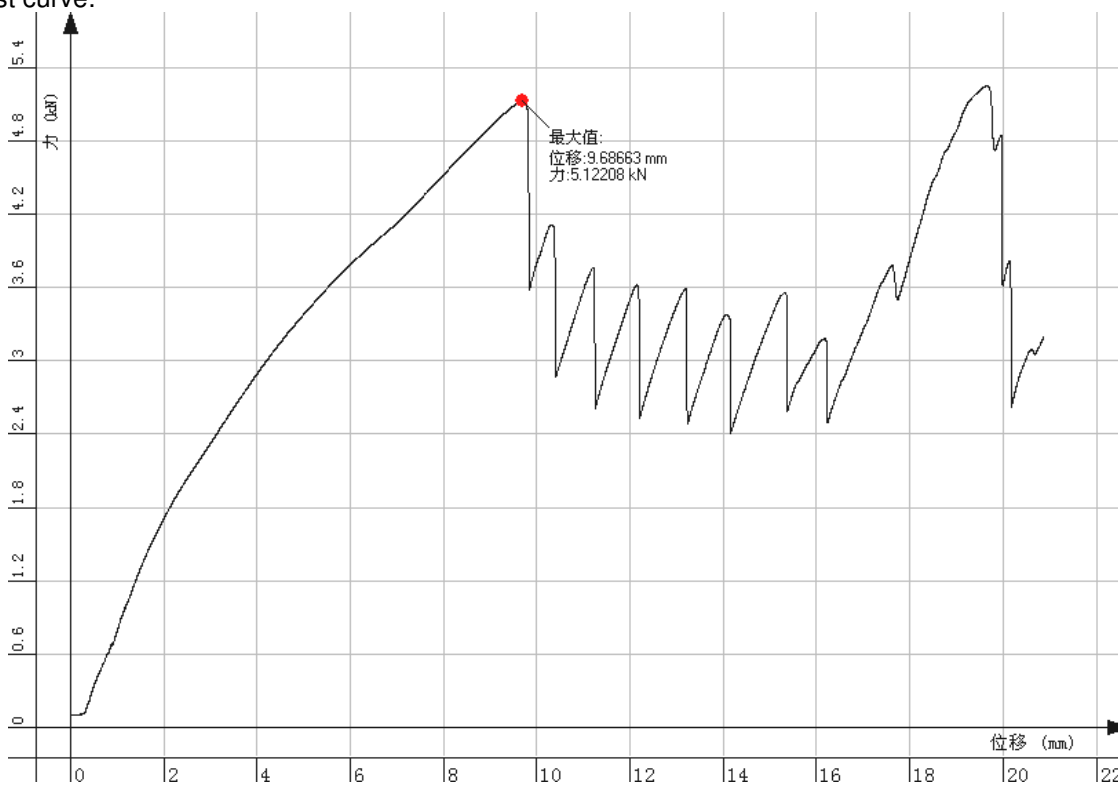
Pull test:

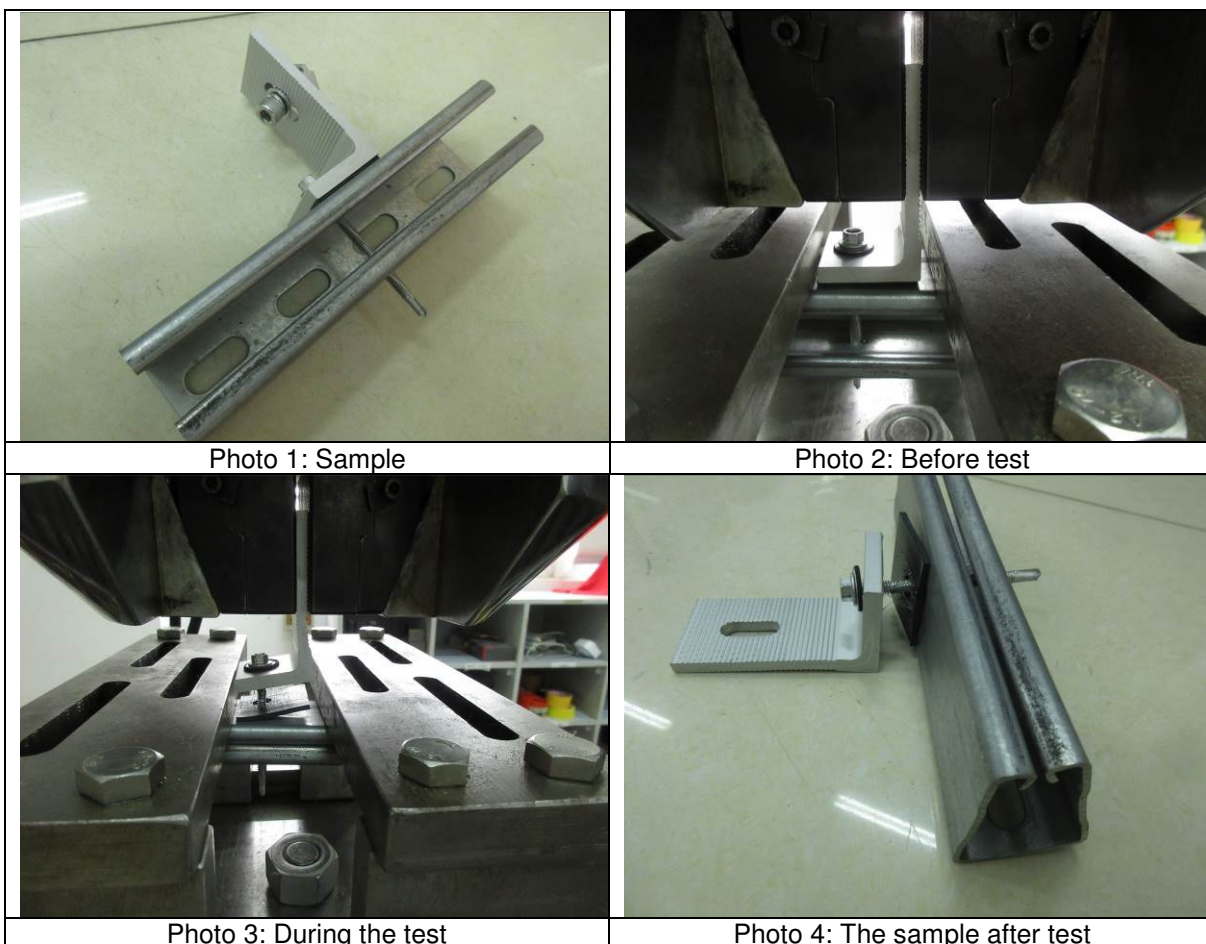


Photo 1: Sample
